DIRECTIONS FOR USE: AG-SERVICES 98 A APotato Sprout Inhibitor \cong is for use to treat potatoes stored in permanent type storage, equipped with internal recirculating fans suitably sized to aerate the potatoes in bulk bins or boxes.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not take internally. Avoid breathing vapour and mist. Protect eyes and mouth when working in a confined space. Only to be used by trained applicators under the supervision of AG-SERVICES INC. Wear chemical resistant gloves when handling the product (e.g. loading). Wear goggles or a face shield and long sleeved shirt and long pants when handling the product. For good hygiene practice, chemical resistant gloves should be worn while handling pest control products.
